SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Meetings with stakeholders took place to create a plan for the use and implementation of the associated funds after the release of the ARP-ESSER LEA allocations. In-house stakeholders included the local teachers association, support staff association, administrator association and managerial/confidential employee association. Discussions also took place with the Board of Education at the monthly April, May and June meetings.

A public survey was released to community members focused on the funds allocated to Hoosick Falls CSD and the nine main areas of funding. A public forum was conducted with community members on June 29, 2021 to review the results of the survey and how the funds would tentatively be used.

In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.**

Due to the CDC/NYSDOH safety guidance, a lack of teaching space and a lack of staffing in the school district, Hoosick Falls CSD was required to implement a hybrid learning model for all UPK-12 students for the 2020-2021 school year. Following changes in the CDC guidance on reopening schools, all UPK-12 students were able to return to full-time in-person learning for the 2021-2022 school year. To accommodate a 100% return to in-person learning for all students, a portion of the funds will be used to hire a 1.0 FTE custodian to handle the increased cleaning needs to sustain a safe environment for student learning.

To allow for safer social distancing options in large public/teaching spaces, furniture will be purchased for the elementary cafeteria, elementary library, and middle school science classrooms. For the 2021-2022 school year, office/room spaces have been redesigned for counselors, speech teachers and AIS teachers. Classroom partitions will be purchased to 'divide' rooms for student learning. Ventilation units will also be installed in these new spaces to increase air flow and fresh air exchange. The elementary office will be redesigned to create safe work stations with increased social distancing between office staff and visitors.

- 4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

A variety of assessments will be administered in the 2021-2022 school year to assess literacy, mathematics and SEL student need. Students in grades UPK-2, special education 3-6 and AIS 3-6 will be administered Fountas & Pinnell reading assessments at the beginning and end of the school year. All students in grades K-8 will be administered pre- and post- NWEA reading and math assessments. All students in grades 5-12 will be administered a pre- and post- Holistic Student Assessment (SEL screener).

In addition to the above assessments, student results from the 2020-2021 school year will be used to help create a baseline for students. These results will include report card data, NYS assessments and midterm/final exams when applicable.

For those students identified by the K-2 Fountas & Pinnell or 3-8 Reading and /orMath for NWEA services will be addressed through AIS instruction. Additional staff will be hired to increase Instructional services by allocating resources differently. Increased services will include AIS, speech, counseling, ENL, classroom aides and core elementary teachers. In the elementary school, classes sizes will be reduced through hiring additional staff. Classroom aides will be hired to assist in transitioning students back into a full-time learning environment and providing both behavioral and academic support in special education classrooms and non-special education classrooms. Academic programming will include Wilson Reading and Foundations. SEL programming will include increased classroom/push-in counseling sessions and Equine Assisted Therapy. Academic programming in the middle school will include the creation of an Academy for students that struggle both academically and behaviorally with a focus on SEL.

The academic design of the building is being restructured to create a 5-8 middle school. This design will allow for a more focused approach by reducing the number of students in each building for faculty, staff and administration. Two administrator stipends will be created to assist as a test coordinator and middle school assistant principal.

Social-emotional programming, professional development and screening will be implemented. Equine therapy through Higher Ground Farm, including equine psychotherapy, will address the significant issues facing some students in grades 5-12. The Holistic Student Assessment (HSA), through the Partnerships in Education and Resilience (PEAR), will be administered to all students 5-12 with embedded professional development for staff.

The remaining funds will be spent on interactive viewboards for classrooms, chromebooks for students to achieve a 1:1 initiative, updated graphing calculators for high school students, a NEC projector and lens for the auditorium, buildings and grounds maintenance truck, an electronic message center and an electronic score board.

7. **In the space provided below, please describe how the LEA will ensure that the interventions it implements, including but not limited to the interventions implemented under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time, will respond to the academic, social, emotional, and mental health needs of all students, and particularly those students disproportionately impacted by the COVID-19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students.**

To address the needs of students, funds will be used to hire 1.0 FTE staff in a number of areas. Two 1:1 aides will be hired to assist special education students and two aides hired to assist in special education classrooms. To reduce class sizes in the elementary, create an AIS Math position and address increased special education needs, the following teachers will be hired: special education, second grade, third grade and high school Spanish. Almost 100% of the ENL needs in the district are in the elementary school. ENL certified teachers in the district are currently located in the high school. The hiring of a high school Spanish teacher will allow latitude to address the increased ENL needs in the elementary school. The district has also seen an almost 100% increase in speech needs for incoming UPK and Kindergarten students. A speech teacher will also be hired to address the increased needs.

To enhance SEL, increase the amount of safe physical activity for younger students and adhere to ADA requirements, additions will be made to the elementary playgrounds. These will include handicap ramps, extended wheelchair pathways, handicapped accessible playground equipment and the replacement/installation of rubberized matting.

As an LEA of over 1100 students, we have an extremely low percentage of students identified as homeless, migrant and in foster care. Each year there are less than 15 in total combined for all three categories. This population is also intermittent within a school year as many families move in and out midyear. This population has remained stable for over 10 years with services being provided in the general fund.

As an LEA, we also have a very small percentage (~5%) of minority students of all ethnicities and races. There is statistically no difference in academics or behavioral success between the ethnic or racial demographic groups.

As an LEA, we have averaged ~50% low-income families for the past decade. Many of our services address this population including the delivery of food to every family in the District since the beginning of the pandemic, including Summer 2020. This included mass distribution of breakfast and lunch on a weekly basis employing all support staff to create the lunches, load buses, hand deliver all lunches, all by bus - up to 5500 meals a week. We have also continued to maintain a safe and healthy work environment by fogging all classrooms on a daily basis, clean all railings, doors, handles and other common-touch areas every day, support an outdoor parent pick-up and drop-off in the elementary school to limit contact with non-employees, and distribute technology (chromebooks and wifi devices) for families in need.

Additional hiring of support staff allow us to continue these services on a daily basis (wiping down of common areas and fogging of classrooms) or when needed (food delivery and technology distribution).

Addressing the at-home needs of low-income families (food, health/safety and technology) helps alleviate the issues faced when the students are not in the building. In-school services can then be provided by AIS, speech, ENL and counseling to address the academic needs.

Approximately every six months, January and July, a review of the submitted ARP Plan and implementation will take place using data gathered at the mid-year and end-of-year points. During the review, the ARP Plan will be cross-referenced with the most recent CDC, NYSDOH and NYSED guidelines and adjusted accordingly. The data used during each review may include NYS exams, midterm exams, final exams, NWEA reading and math assessments, Fountas and Pinnell assessments, speech language and articulation assessments, IEP goals, Holistic Student Assessment, report card information, attendance, discipline, enrollment and graduation rates.

These results will be communicated to the stakeholders involved in creating the ARP Plan; teacher, administrator, support staff and managerial/confidential associations, Board of Education and public. A State of the Schools report will be generated in July addressing the goals of the plan, student results, and changes in guidance by the CDC, NYSDOH and/or NYSED. The information will be disseminated at the monthly BOE meeting, through meetings with said associations and through a virtual public forum.
